ADVOCACY

The Blue Water Area Child Advocacy Center, a program of the St. Clair County Child Abuse/Neglect Council, keeps alleged child sexual abuse Victims at the center of a coordinated, child-sensitive interview process and helps ease the pain of this tragic situation.

The hallmark of our center is strict attention to the needs of children. It is designed as a safe place for children to be heard and ensures that they are not further victimized by the systems designed to protect them.

The result is that a child tells his or her story just one time to a trained professional in a caring atmosphere. The CAC team takes it from there and the healing begins.

The Blue Water Child Advocacy Center began operation in December 2007. The Forensic Interviewer now conducts an average of three or more interviews each week. The center operates at no cost to the professionals requesting interviews and is supported by the donations and monetary gifts of a caring community.
